RGS DAILY WASH

DIRECTIONS: (Rollers) Apply full strength or mix with up to 30% water across the top of the roller. Allow to run down the roller train for a few minutes and engage wash-up blade. Reapply if necessary until fluid runs clear into the wash-up tray. (Blankets) Apply full strength or premixed with up to 30% water with a saturated cloth on the blanket. (Automatic Units) Can be used in all units. Test on plates before using. For use only as a roller and blanket wash. Before using, read the SDS for more detailed regulatory and hazard information.

HANDLING AND SPILL CONTROL PROCEDURES: Open bung slowly to allow air to escape. Avoid breathing vapors. Impervious or chemical resistant gloves, clothing and eye protection recommended. **For Spills:** Absorb material with ground clay or similar absorbent material, then place material into approved containers for removal. **Do not reuse this container. For industrial use only.**
